

The Museum of Glass and Jewellery in Jablonec nad Nisou

PARK REGULATIONS

The park is the property of the Czech Republic and is administered by the Museum of Glass and Jewellery in Jablonec nad Nisou. **These regulations are binding for all visitors.**

- 1. The use of the park, including play equipment, is at the visitors' own risk. The Museum assumes no liability for damage, injury or accident caused by carelessness while in the park or failure to comply with these regulations.
- 2. Visitors are obliged to observe basic rules of courtesy, respect for other visitors and all equipment, to keep the grounds tidy and clean, and to dispose of rubbish in the bins provided.
- 3. Visitors must use only designated paths to move around the park. It is forbidden to damage the equipment and furnishings of the park, including exhibits, greenery and children's play equipment.
- 4. The use of motor vehicles, bicycles, scooters, roller skates, segways, skateboards and similar devices is prohibited throughout the park. Motor vehicles may enter the forecourt from Lipanská Street solely with the permission of the operator. In addition, it is prohibited to throw or kick balls or other objects.
- 5. School-age children are allowed to enter alone in order to pass safely. Use of the play equipment and facilities is only permitted when accompanied by a responsible adult.
- 6. The consumption of alcohol and the use of addictive substances is prohibited (with the exception of alcoholic beverages served at Museum events).
- 7. Dogs are not permitted to roam freely, and owners are responsible for cleaning up any excrement left behind.
- 8. Open flames, fire, firearms, bladed and stabbing weapons, explosives of any kind, incendiary or otherwise dangerous substances or objects are strictly prohibited in all areas.
- 9. It is prohibited to disturb other park visitors and residents of adjacent properties by excessive noise. Overnight camping is prohibited on the grounds.
- 10. Visitors are required to obey the instructions of the park staff in relation to the protection of the exhibits on display, the safety of visitors, the protection of equipment and ensuring compliance with the rules set out herein. Failing to do so will result in visitors being removed from the park by park staff.
- 11. The park area is under surveillance by a security camera system. Visitors to the park, including participants in officially organised events, acknowledge and consent to the taking of audio and visual recordings for the purposes of the museum and to the reasonable publication of these recordings in the usual way (on the website, in the media, in promotional materials, etc.).
